1. The term gift as used here applies to any physical object or objects described on the front page of this form.
2. The GJGMC officers, Board of Directors and members shall not be held liable to any extent for loss, destruction or damage to any gift item donated to the GJGMC for and purpose regardless of any stipulations concerning the disposal of the gift if no longer wanted by the GJGMC.
3. When the GJGMC deems it is in its interest to dispose of the gift item donated to it and the donor has requested its return, the GJGMC will by telephone, e-mail or by letter to the donor's last known address notify the donor of the desire to dispose of the gift item.
4. If the conditions of items 2 apply. The donor agrees to claim the gift within 90 days. If the donor has not exercised his/her right to claim the gift item within 90 days of being officially notified, the GJGMC's desire to dispose of the gift item, the officers and Board of Director of the GJGMC will dispose of the gift item in any manner that they deem to be appropriate.
5. In the event that a donor has requested the return of a gift item that the GJGMC no longer wants and the donor is deceased, the GJGMC will make a good faith effort to notify the surviving spouse or family member of its desire to return or otherwise dispose of the gift item. If the surviving spouse or family member has not claimed the gift item within 90 days, the officers and Board Directors of the GJGMC will dispose of the gift item in any manner that they deem to be appropriate.
6. If the GJGMC no longer wants a gift item and the donor has made a specific request as to its disposition other than returning it to the donor, the GJGMC will make a good faith effort to honor the request. Any cost incurred in delivering the gift to a third party will be borne by the donor or the third party. In the event that a third party is notified of the gift and has not made arrangements to receive it within 90 days the officers and Board of Directors of the GJGMC will dispose of the gift item in any manner that they deem to be appropriate.
7. In the event of dissolution of the GJGMC, the donor recognizes that the remaining officers, Directors and/or members may not be able to meet the obligations as to disposition of the gift items and agrees to hold harmless such officers, Directors and members if the gift item is not disposed of in accordance with the terms of this receipt.
